BUSINESS ACHIEVEMENT - Business leader or leader in a professional trade - includes sales and marketing, entrepreneurs and leaders in innovative endeavors

BANKING & FINANCE - Banking, accounting, financial planning, investors, other finance-related business and those who contribute to the success of the financial industry

GOVERNMENT & LAW - Individuals serving local, state, or federal government, law, politics or military service

HEALTHCARE & STEM - Leader in the fields of healthcare, science, technology, engineering or math

NONPROFIT & COMMUNITY SERVICES - Employee or volunteer of a nonprofit entity, human services or social services

HUMANITIES & EDUCATION - Leader in any level of education, culture, arts, music, literature, philosophy or religion

YOUNG WOMAN OF ACHIEVEMENT - Woman between the ages of 21 and 35 with community service and professional success to indicate both current leadership and her potential for extraordinary leadership and service

SYLVIA HENKIN MENTORING AWARD- Woman who has dedicated herself to mentoring other women in their personal/professional lives

EMBELIEVER AWARD - A man, woman, or business that demonstrates the mission of EmBe to enrich our community by empowering women and families

NOMINATION REQUIREMENTS

Any corporation, agency, civic organization, school, place of worship or other group/individual may nominate a deserving woman for a specific Tribute to Women Award. A man or business may also be nominated for the **EmBeliever Award**.

Previous winners may not be re-nominated in the same category. Nominations for women who have been previously nominated but have not received awards may be submitted. EmBe staff and Tribute to Women judging committee members are not eligible. You can not nominate a relative.

Please answer the following questions, using **specific examples** that demonstrate the involvement, achievement and leadership of your nominees. **Please do not use the name or current place of employment in the nomination narrative. 750 word max.**

1. What qualities does your nominee possess that make her an effective leader in her field?

2. How has your nominee demonstrated skill development and growth within the category of her nomination?

3. What achievements has your nominee made, personally and/or professionally, that are evidence of their qualification for the EmBe Tribute to Women Award?

4. Please share a brief story that illustrates a specific contribution made by your nominee, as well, their overall impact in their business, organization, and community.

The nominator certifies the submitted information is true. A selection committee of prominent community leaders will review all nomination forms and select the Tribute to Women award recipients. Winners will be announced at Tribute to Women on Thursday, April 30, 2015 at the Washington Pavilion. **Winners are not notified prior to the event.** The nominator understands the importance of being present at the Tribute to Women awards program and will purchase tickets to attend with the nominee.
