THE CENTERS UTILIZE THE CREATIVE CURRICULUM AND THE SPARKS PHYSICAL EDUCATION CURRICULUM. THESE PROGRAMS PROVIDE THE NECESSARY EDUCATION AND CARE TO ADDRESS THE INDIVIDUAL NEEDS OF THE CHILDREN. EMBE UTILIZES A SLIDING FEE SCALE FOR FAMILIES THAT MEET INCOME GUIDELINES. DISCOUNTED SERVICES WERE PROVIDED TO 27% OF THE CHILDREN SERVED.
