*Application Fees: To reserve your spot, a non-refundable application fee of \$150 per child is required.

ENROLLMENT OPTIONS TO SERVE YOUR FAMILY BEST

We believe there is dignity in providing for one's family, and scholarships create opportunities that remove barriers for families to do so. We know that life and living expenses can be overwhelming, and we're here to ensure that reliable childcare is accessible to all.

CHILDCARE ASSISTANCE (CCA)

- Child Care Assistance is a federal subsidy program administered by the Department of Social Services that helps with childcare tuition costs.
- Their subsidy **may cover up to 90% of your tuition cost!**
- Not all providers accept Child Care Assistance. Not only does EmBe accept it, but we also have team members dedicated to aiding you through the application process and the program.
- Since you cannot apply for CCA until 30 days prior to the child's start date in our program, please reach out to Sadie Mudder on our team via the contact information below to discuss potential eligibility. You can still enroll at EmBe Education-Madison today.
- **We highly encourage you to apply!** If it's your family's first time applying, or you are unsure if you qualify, reach out to Sadie Mudder on our team via the contact information below.

EMBE SCHOLARSHIP

- Our EmBe Education Scholarship Fund is available to those in the middle-middle, who do not qualify for Child Care Assistance but are still in need of financial assistance.
- **Our Scholarship Fund can help cover up to 20% of your tuition cost.**
- EmBe also offers scholarships to help cover application fees to enroll at an EmBe location.

SPECIAL CIRCUMSTANCE

- Our Special Circumstance Scholarship is typically a temporary scholarship designed to assist an EmBe family for a period of time to help with extenuating circumstances. Sometimes that is to help during medical crises, loss of job, or other factors. Reach out to Sadie Mudder on our team, and she can assist you!

OTHER EMBE OPPORTUNITIES

- **Come work with EmBe and receive a tuition discount!** Full-Time Employees (30 hours+/week) receive a 65% discount. Part-time employees (10 hours+/week) receive a 30% discount. This can be used in tandem with CCA. To apply, go to embe.org/careers!

SCHOLARSHIP GUIDELINES

Do I Qualify?

Find your gross monthly or annual household income in the ranges below to see which tuition tier you qualify for. Tier 1 lists the maximum income to qualify for that tier. Your tier indicates the weekly tuition amount you would pay, rather than the standard rate of \$255 per week.

Examples:

- A family made up of mom, dad, and three children, making \$5,000/month, would qualify for a 30% discount, which would make their tuition \$178.50/week.
- A family made up of mom, dad and one child, making \$85,000/year would receive a 20% discount, which would make their tuition \$204/week.
- A single mom with 1 kid making \$72,000 would qualify for a 10% discount, which would make their tuition \$229.50/week
